The Superintending Engineer, West Bengal State Rural Development Agency on behalf of West Bengal State Rural Development Agency invites the percentage rate bids, in electronic tendering system, for **Upgradation** of roads under Pradhan Mantri Gram Sadak Yojana (PMGSY II) for each of the following works including their **Maintenance** for five years from the eligible and approved contractors registered in the web-site www.pmgstenderswb.gov.in

3. **Cost of Bid Form:** Rs 5,000.00 per package (*non-refundable*) only the amount should be deposited in State Bank of India in the Account No 00000011143673802 in favour of "WBSRDA (SNA)" IFSC No SBIN0014524 through RTGS/NEFT/CBS System only. The package number and UTR number should be clearly mentioned in the deposit challan. Payment made otherwise will be rejected.

Cost of Bid Security should be deposited in ICICI Bank Account No. 105601001960 in favour of: "WBSRDA PMGSY EMD AC", IFSC No ICIC0001056 through RTGS/NEFT/CBS System only. The package number and UTR number should be clearly mentioned on the deposit challan. Payment made otherwise will be rejected.

4. **Availability of Bid Document and mode of submission:** The bid document is available online and bid should be submitted online on website www.pmgstenderswb.gov.in. The bidder would be required to register in the web-site which is free of cost. For submission of bids, the bidder is required to have valid Digital Signature Certificate (DSC) from one of the authorized Certifying Authorities (CA). Aspiring bidders who have not obtained the user ID and password for participating in e-tendering in PMGSY may obtain the same from the website: www.pmgstenderswb.gov.in

Digital signature is mandatory to participate in the e-tendering. Bidders already possessing the valid digital signature issued from authorized CAs can use the same in this tender.

5. **Submission of Original Documents:** The bidders are required to submit **original documents such as Bid Security, Cost of Bid document and Affidavit** regarding correctness of information furnished with bid document as per provisions of Clause 4.4B(a) (ii) of ITB with Superintending Engineer WBSRDA, HC-7Bidhan Nagar, 6th. Floor, Kolkata-700106, on a date as specified in Section I, either by registered post or by hand in the box, kept in the office of the undersigned failing which the bids shall be declared non-responsive.

6. **Last Date/ Time for receipt of bids through e-tendering:** 17/01/2023 (dd/mm/yyyy) up-to 18:00 Hours (time)

7. The site for the work is available.

8. Only online submission of bids is permitted, therefore; bids must be submitted online on website www.pmgstenderswb.gov.in. The technical qualification part of the **bids will be opened online at 11:00 Hours** (time) on 24/01/2023 (date) by the authorized officers. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened online on the next working day at the same time.

9. The bidder is not required to quote his rate for routine maintenance. The rates to be paid for routine maintenance are indicated in the Bill of Quantities. Further, the payment for routine maintenance to the contractor shall be regulated based on his performance of maintenance activities.

10. The bids for the work shall remain valid for acceptance for a period not less than ninety days after the Opening of Financial Bid.

11. Bidders may bid for any one or more of the works mentioned in the Table above. To qualify for a package of contracts made up of this and other contracts for which bids are invited in the same NIT, the

bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts.

12. Other details can be seen in the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the Employer shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to the tender.

13. To keep the road in good condition during the next 5 years after the completion of the construction if any additional / excess work is required over the stipulated quantity in the schedule for routine maintenance work, the same will be treated as defect liability and the Contractor has to do the maintenance work at his own cost.
